1. STATEMENT OF PRINCIPLES

The policy outlines the commitment of the staff, pupils and governors of Manor Beach Primary School to ensure that equality of opportunity is available to all members of the school community. For our school this means not simply treating everybody the same but understanding and tackling the different barriers, which could lead to unequal outcomes for different groups of pupils in school, whilst celebrating and valuing the achievements and strengths of all members of the school community. These include:

- Parents / carers
- The governing body
- Multi-agency staff linked to the school
- Visitors to school
- Students on placement

We believe that equality at our school should permeate all aspects of school life and is the responsibility of every member of the school and wider community. Every member of the school community should feel safe, secure, valued and of equal worth.

At Manor Beach Primary School equality is a key principle for treating all people fairly and creating a society in which everyone has the opportunity to fulfil their potential - irrespective of their gender, ethnicity, disability, religion or belief, sexual orientation, age or any other recognised area of discrimination.

3. SCHOOL IN CONTEXT

There are 228 pupils on role at Manor Beach Primary School. Of which 118 are boys and 110 are girls. 84 pupils are eligible for Free School Meals. The following table highlights the ethnicity of the pupils who attend Manor Beach Primary School.

The school is physically accessible with a ramp to enter both main entrance and entrance from the car park at the rear of the building. Staff assist pupils who require support to access the playgrounds, toilets, cloakrooms and the office. Pupils who have difficulty in lining up with their class in the morning will be met by support staff at the office to assist them to their classrooms. At the end of the day some parents / carers meet their child at the office.

4. ETHOS AND ATMOSPHERE

At Manor Beach Primary School the leadership of the school community will demonstrate mutual respect between all members of the school community. There is an openness of atmosphere, which welcomes everyone to the school.

All within the school community will challenge any type of discriminatory and / or bullying behaviour, e.g. through-unwanted attentions (verbal or physical) and unwelcome or offensive remarks or suggestions. All pupils are encouraged to greet visitors to the school with friendliness and respect.

The displays around the school are of a high quality and reflect diversity across all aspects of equality of opportunity and are frequently monitored. Provision is made to cater for the spiritual needs of all the children through planning of assemblies, classroom based and non-classroom based activities.

5. MONITORING AND REVIEW

Manor Beach Primary School is an inclusive school, working towards greater equality in the whole school community. We use the curriculum and teaching to enhance the self-esteem of all those it serves and to provide a learning environment in which each individual is encouraged to fulfil her or his potential.

We make regular assessments of pupils' learning and use this information to track pupils' progress, as they move through the school. As part of this process, we regularly monitor the performance of different groups, to ensure that all groups of pupils are making the best possible progress. We use this information to adjust future teaching and learning plans and support / intervention as necessary.

Resources are available to support groups of pupils where the information suggests that progress is not as good as it should be. The governing body receives regular updates on pupil performance information, usually via its Standards and Effectiveness Committee.

School performance information is compared to national data and Local Authority data, to ensure that pupils (and groups of pupils) are making appropriate progress when compared to all schools, and to schools in similar circumstances.

As well as monitoring pupil performance information, we also regularly monitor a range of other information. This relates to:

□ Attendance
☐ Exclusions and truancy
$\ \square$ Racism, disability, sexism, homophobia and all forms of bullyin
☐ Parental involvement
☐ Participation in extended learning opportunities.

Our monitoring activities enable us to identify any differences in pupil performance and provide specific support as required, including pastoral support. This allows us to take appropriate action to meet the needs of specific groups in order to make necessary improvements.

Manor Beach Primary School is also committed to providing a working environment free from discrimination, bullying, harassment and victimisation. We aim to recruit an appropriately qualified workforce and establish a governing body that is representative of all sections of the community in order to respect and respond to the diverse needs of our population.

We collect and analyse a range of profile information for our staff and governors. This involves applicants for employment, attendance at training events, disciplinary and grievance cases, and staff appraisal. All information is stored securely and is confidential.

6. DEVELOPING BEST PRACTICE

Teaching and Learning

We aim to provide all our pupils with the opportunity to succeed, and to reach the highest level of personal achievement. To do this, teaching and learning will:

Learning Environment
There is a consistently high expectation of all pupils regardless of their gender, ethnicity, disability, religion or belief, sexual orientation, age or any other recognised area of discrimination. Parents / carers are also encouraged to view their own children's achievements in this light.

The provision of good quality resources and materials within Manor Beach Primary School is a high priority. When ordering new resources and materials we consider how they show equality. These resources should:

 Show positive images of males and females in society; Include non-stereotypical images of all groups in a global context; and Be accessible to all members of the school community.
Language
We recognise that it is important at Manor Beach Primary School that all members of the school community use appropriate language which:
 Does not transmit or confirm stereotypes; Does not offend; Creates and enhances positive images of particular groups identified at the beginning of this document; Creates the conditions for all people to develop their self-esteem; and Uses accurate language in referring to particular groups or individuals and challenges in instances where this is not the case.
Extended Learning Opportunities
It is the policy of this school to provide equal access to all activities from an early age. We undertake responsibility for making contributions to extended learning opportunities and are aware of the school's commitment to equality of opportunity e.g. sports helpers, coach drivers.

Staff Recruitment

Partnerships with Parents / Carers / Families and the Wider Community
We will work with parents / carers to help all pupils to achieve their potential.

Roles and Responsibilities
 Our governing body will ensure that the school complies with statutory requirements in respect of this policy and action plan; The headteacher will review the policy and action plan, usually on an annual basis; The headteacher is responsible for the implementation of this policy, and will ensure that staff are aware of their responsibilities and are given necessary training and support and report progress to the governing body. She also has day-to-day responsibility for co-ordinating the implementation of this policy;

8. COMMISSIONING AND PROCUREMENT

Manor Beach Primary School will ensure that we buy services from organisations that at least comply with equality legislation. This will be a significant factor in any tendering process.

9. PUBLICISING THE POLICY AND PLAN

10. ANNUAL REVIEW OF PROGRESS

The school is legally required to report annually on its progress and performance in respect of the policy covering ethnicity, disability and gender and to report annually on its progress to improve access for disabled pupils, including access to the curriculum, physical access and access to information. Taking this single equality approach, we will incorporate all requirements into one annual report, which meets the requirements of the new legislation and which will formulate the basis for the annual action plan.

11. EQUALITY IMPACT ANALYSIS
